PARTNERS IN EDUCATION WITH PARENTS PLAN INFORMATION:

PEP allows you to cover up to 100 percent of University charges (tuition, fees, room, and board) less charges covered by scholarships or other loans. You can participate in one of four ways:

- Multiyear Option: Borrow up to 4 years of covered charges at the entering-year rate and repay over 10 years at a fixed interest rate of 6.25 percent per year.
- Prepayment Option: Prepay all or part of undergraduate charges at the entering-year rate.
- Annual Option: Borrow annually for current charges and repay each loan over 10 years at a fixed interest rate of 7.25 percent per year. (Future-year loan interest rates may be different.)
- Combination Option: Prepay some charges with the Prepayment Option and borrow the rest using the Multiyear Option.

If you prepay entirely, complete only the shaded sections. If you borrow or select a combination, complete the entire application.
